At the October Midterm Executive Board meeting, a motion was made and approved to send the 2023 Credentials both electronically or via US Mail to the State Reps, Officers and Past Presidents. The reason for doing this is to reduce the cost of copying and mailing for the Parliamentarian (who submits an expense report for reimbursement) and the State Reps, Officers and Past Presidents from ensuring they return their credential form by the deadline. In order to ensure this is properly communicated, an email will be sent no later than January 15 advising of the process to be followed in sending out and returning the forms for 2023. The option to have the credentials sent and returned via US Mail will continue to be in place. If this change proves to be successful, a motion to change Standing Rule IV. Publications Letter C will be proposed.

While reviewing the October Midterm Executive Board meeting minutes, I realized I should have included in my November/December Presidential Papers report that a discussion was held on increasing the State Meeting registration fee. Article 9, Section 3 of the NYSOMOTC By Laws states "The non- refundable fee to cover expenses shall be set by the host club with the approval of the Executive Board." In addition, Standing Rule I. Meetings Letter B. Fees iv. states "The increase of registration fees applies equally to the Midterm Executive Board meeting and the annual State meeting." The reason for this increase is due to the costs the hosting club are being charged for meeting rooms as well as the Saturday night event. After discussion, a motion was made and carried to increase the Registration Fee for Midterm and the State Meeting to \$50. I know Third Call has been distributed and the increase was reflected on the registration form and apologize for not including the background/reason for the change in my last report.

Happy Winter Everyone,

The MSS Committee is looking forward to receiving applications! We have received some inquiries and hopefully will have a nice pool of applicants come February. Our next committee meeting is scheduled for early February to review the judging process so everything runs smoothly. There is still time to apply, so please continue to spread the word to your clubs to encourage eligible students to email us for an application (nysomsscholarship@gmail.com). Students can request the application from us anytime and begin to collect all the required documents. The deadline for submission is February 20, 2023 -- and it is right around the corner!!

Checklist for Eligibility

1. An unmarried offspring who lives at home with their parent or legal guardian. The parent or legal guardian must currently reside in New York State and has for the last five years.

2. Applicant must be a high school graduate or equivalent and completed at least one term of post-secondary education. A GPA of 2.50 or higher is required.

3. Attached application must be completed and returned.

4. A complete personal resume is required. It should include all work history, education, plus involvement in any extracurricular activities, clubs, civic or community service.

5. At least two letters of recommendation that state the strengths and character of the applicant. The name, address, and phone number of the person writing the recommendation, as well as, the nature of the relationship and the length of time the applicant is known by said individual must be included.

6. Official sealed copies of academic transcripts from High School, College, or other accredited educational institutions attended. If the Applicant is a college Junior, Senior or Post Graduate, the High School Transcript is not needed.

7. Applicant must submit a 250-400-word essay. The title must be "How Higher Education Will Affect My Future." The essay must be typewritten, double-spaced and printed on white paper only.

8. Copies of Birth Certificates for the applicant and the multiple birth children (to verify multiple birth family status).

9. All documents need not be sent at the same time but must be postmarked no later than February 20th. In the lower left-hand corner of all envelopes it must be written, "To be opened by the MSS Chairman only."

We are privileged to give away up to (2) \$1,500 scholarships in May of 2023 to two students of multiplebirth families who meet the criteria. On behalf of the MSS Committee, we look forward to reviewing all the applications and awarding two scholarships at Convention. Remember, all required documents will need to be submitted to me by February 20, 2023. Please continue your support of this scholarship by purchasing your favorite, lucky dates for the calendar drawing—you could win big at Convention! The MSS Scholarship Fund appreciates your contributions very much. We also accept donations for our raffle table at Convention.
