

As I sit writing this newsletter report, the temperatures are in the 50s and the sun is peeking through the clouds. While I know Punxsutawney Phil said we have six more weeks before spring, I'm wondering if Old Man Winter didn't get the message!!

As it is not an election year at our NYSOMOTC State meeting in April, the responsibilities of the Nominating Committee are minimal. We will, however, begin to gear up for next year when all elected offices will be vacated. I am hoping to have a meeting with the committee at the State meeting to begin to plan our strategy.

It is never too early to begin thinking about what your role in the State organization will be starting in 2025. For this reason, I am including a description below of the elected offices: President: serves as the official representative of the NYSOMOTC. They work with the Executive Board to provide a smooth-running organization, to initiate new projects, answer questions and resolve conflict. They appoint the Parliamentarian and the Advisor as well as the Standing Committees and Special Committee Chairpersons. They work with the State Meeting Co-Chairpersons to ensure the success of the annual State Meeting.

Vice President: serves as the second in command, working closely with the President. As the official NYSOMOTC Clubs Liaison, they handle all matters related to the Membership and encourages non-member clubs to join.

Treasurer: has the custody of the NYSOMOTC General Fund and the Eleanor Siegel Memorial Fund. Works with the President to formulate an annual proposed budget, pays vouchers, manages the bank accounts, prepares bi-monthly financial reports for the Presidential Papers, files the annual IRS Form 990, prepares the Midterm and year-end Financial Reports and presents the financial books for Audit at the State Meeting.

Recording Secretary: digitally records and takes the minutes at the annual State Meeting and the Executive Board Meetings. They call the Roll at the meetings. Using their notes and the recordings, they work with the Minutes Approval Committee to produce the Official Minutes of each NYSOMOTC Meeting. At the State meeting, the Nominating Committee will have two handouts which will be provided to all attendees at the Saturday General meeting - the NYSOMOTC Executive Board Job Descriptions and the

Eligibility Qualifications for Executive Board members which includes a section on how to become an elected officer as well as to become President. The Nominating Committee would welcome an opportunity to answer any questions you might have in regards to joining the Executive Board or being considered for an elected office. Resume forms will also be available.
