## **Eligibility Qualifications for Executive Board Members**

## To become a Member of the Executive Board:

- 1. Must be a member of a member club. (Bylaw Article III Section 2)
- 2. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 3. Appointed by the President. (Bylaw Article VIII Section 1 A.)

### To become the Nominating Chairperson:

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- 2. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 3. Must have served on the Executive Board for the last 2 years including the current year. (Bylaw Article VII Section 1 B)
- 4. Must be present at the Saturday General Meeting. (Bylaw Article VII Section 1)
- 5. Elected by membership. (Bylaw Article VII Section 1)

#### To become a Member of the Nominating Committee:

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- 2. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 3. Must be present at the Saturday General Meeting. (Bylaw Article VII Section 1)
- 4. Elected by membership. (Bylaw Article VII Section 1)

## To become Chair or Co-Chair of a State Meeting:

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- 2. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 3. Should present Bid in writing to the President. (Bylaw Article IX Section 4 A)
- 4. Must be present at the Saturday General Meeting. (Bylaw Article IX Section 4)
- 5. Hosting site must be elected by membership. (Bylaw Article IX Section 4)

## **Eligibility Qualifications for Executive Board Members**

# To become an Elected Officer:

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- 2. Local club must have been a member of NYSOMOTC for at least 1 year. (Bylaw Article VII Section 2)
- 3. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 4. Must have served as an Officer or Chairperson on the Executive Board or held an Elected Office in their local club. (Bylaw Article VII Section 2)
- 5. Elected by membership. (Bylaw Article VII Section 5)

#### **To become President:**

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- Local club must have been a member of NYSOMOTC for at least 1 year. (Bylaw Article VII Section 2).
- 3. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 3)
- 4. Must be a member of the current year's Executive Board. (Bylaw Article VII Section 2)
- 5. Must have served as an Officer or Chairperson on the Executive Board in the past five (5) years, excluding the current year. (Bylaw Article VII Section 2B ii)
- 6. A Past President must attend at least two (2) Executive Board Meetings during the current year to be considered active. (Bylaw Article VII Section 2C)
- 7. Elected by membership. (Bylaw Article VII Section 5)
- 8. All Officers take over their duties as of the close of the Saturday General Meeting at which they were elected. (Bylaw Article V Section 2)

### To become an Appointed Officer:

- 1. Must be a member of a member club. (Bylaw Article VII Section 2)
- 2. A resume must be on file with the Nominating Chairperson. (Bylaw Article VII Section 2)
- Appointed on advisement of the President by the Executive Board. (Bylaw Article V Section 1B)
