Treasurer

Good morning, ladies.

I recently agreed to step in as Treasurer after Melissa submitted her resignation to President Pam. In speaking with Pam, Melissa, and my local Chase branch, over the past few weeks, it seems to be the quintessential comedy of errors!

Initially, there seemed to be some confusion with different bank branches about who could handle the transfer of the accounts. From what I understood, it was determined that the President had to be the one to handle the transition. Pam was then issued a debit card which was inadvertently connected to the Marie Simmons Scholarship Fund account. Over a couple months, four charges were then debited from the MSS account as opposed to the general fund. Once that was brought to my attention, I connected with Melissa, and she provided me a check for the total amount of those charges (as you will see in reviewing both accounts). How did I not know that was happening you ask? It was only then that I realized that I was not getting the monthly statements for the MSS Account. (I had specifically set the account up to receive monthly paper statements so I could balance the account on a monthly basis!) So, I logged on to my chase account for the MSS Fund and saw that the statements were changed to paperless statements, and the address was changed to Melissa's address. When I spoke with the bank representative to change the MSS account back to my address, he said I could not request that change, that the President was the "overseer" of all the accounts. In other words, she was the only one who could request or discuss anything to do with the accounts. He further advised me that the address could not be changed as all the accounts had to use "the business address"!!! So that is something that needs to be addressed!

Also, upon reviewing the books and preparing the financial reports, there were two fraudulent Amazon charges from Melissa's debit card. In speaking with her, she does not know where they came from and thus spoke with the bank. They reversed the charges and issued her a new debit card. Amazon also "returned" one of the charges and then corrected their reversal.

Hopefully this will all make some sense as we review the reports! The issues have been corrected, but I think we will need to think about the use of debit cards and more so, possibly a different bank!

It was great “seeing” everyone at our virtual Executive Board Midterm meeting on October 18. Congratulations to President Pam Reussow for a very productive meeting.

My report to the Board highlighted the following:

I assisted the President with the electronic votes which took place for:

- o The change of date for the 2027 State Meeting due to Passover (which had to be approved by both the Executive Board and the member clubs).
- o The electronic vote to accept the bid made by Pam Reussow and Lori Connolly to host the 2027 State Meeting and for it to be held in Binghamton.
- o The results of these electronic votes were reported by President Reussow at the Midterm Board meeting.

I reviewed and provided my feedback for the Friday Executive Board Meeting, Saturday General Meeting and the Sunday Executive Board Meeting minutes.

I created a new document to correctly reflect Easter and Passover for 2026 – 2050. This document is based on a Google search (Easter) and consulting with Congregation Shema Yisrael’s Rabbi (Passover).

On behalf of the Marie Simmons Scholarship (MSS) Committee and with the assistance of Myriam Lavora, Chairperson of the MSS Committee, proposed changes to the MSS Procedural Guidelines (Bylaws) #8 were reviewed and approved for recommendation to the member clubs. In addition, on behalf of the Budget ad hoc committee and the Future State Meeting ad hoc committee, both appointed at the Sunday, April 27 Executive Board meeting, four proposed amendments were presented to the Executive Board for their consideration. Three of the amendments (Article IV DUES AND FISCAL YEAR Section 1 DUES, Article IX STATE MEETINGS Section 4 Invitations and Standing Rule I MEETINGS Expenses) were approved for recommendation to the member clubs. The fourth amendment (Article VI EXECUTIVE BOARD Section 3 MEETINGS) had two parts to the proposed change. Only one part was approved for recommendation to the member clubs. The other part was tabled for additional discussion at the Friday, May 1 Executive Board meeting.

As a result, the MSS Procedural Guidelines (Bylaws) #8 amendments and the Bylaws amendments referenced above as approved for recommendation will be included with the Credential mailing in February. These will be voted on at the Saturday General meeting on May 2, 2026. As Parliamentarian, I would encourage you to review these documents with your membership and to be prepared with any questions/recommendations you might have at that meeting.

I wish each of you a joyous holiday season with family and friends and a prosperous and Happy New Year!
